On March 21, 2022, the Singapore Hotel Association (SHA) and Singapore Tourism Board (STB) launched the Hotel Sustainability Roadmap at the inaugural Hotel Sustainability Conference and Marketplace.

In line with the Singapore Green Plan 2030, the roadmap focuses on four core areas of focus (water conservation, energy conservation, waste management, and sustainable sourcing), with two targets:

- 1. At least 60% of hotel room stock to achieve internationally recognized hotel sustainability certification by 2025
- 2. For hotels to commence tracking emissions by 2023 and reduce emissions by 2030, with the goal to achieve net-zero emissions by 2050

Singapore envisions a leading sustainable hotel industry that integrates sustainability as a core value across the entire hotel ecosystem. The roadmap also aims to establish Singapore's hotel industry as a living lab that uses sustainability to drive competitiveness and growth.

Requirements for submission of artwork for web:

- a) For digital artworks on SHATEC Hospitality Conference 2023 website: Accepted digital files include GIF (max limit of 3 loops/15 seconds, afterwards the animation should end), JPG, PNG.
 - Please provide an active click-through URL for all ads.
 - All ads should be 72 DPI and in RGB colour.
- b) *For logos:* Vector EPS or AI file preferred, with all fonts converted to outlines. Minimum 300 DPI resolution.
 - The image file may also be delivered in any of the following formats: PSD, PNG, or JPG.
 - Any images received at larger file sizes will be reformatted to meet web requirements.
 - Ideally, two separate files should be submitted:
 - 4-color (CMYK) or RGB logo
 - One-color (black & white) logo with no tints or screens (i.e., 100% black, no gray)
 - Please submit any logo usage guidelines along with your logos, if applicable.
- c) For EDM: 600 pixels max width; JPG or GIF images should be hosted on advertiser website; no rich media, attachments, scripts or automatic downloads. All style/CSS must be embedded within the HTML. External CSS not accepted.
 - Please provide an active click-through URL for all ads.
- d) For social media brand post: For uploading to LinkedIn, Facebook and Instagram
 - 1080 by 1080 pixels or according to recommended size guidelines for LinkedIn, Facebook and Instagram, in image or video format, JPG or MP4 file preferred
 - Please provide the post caption accompanying the media file (image/video).
